

Negotiated insurance for accident cover

Extension of insurance against non-occupational accidents according to the Federal Law on Accident Insurance of 20 March 1981

Mandatory accident insurance

If you work for an employer for at least eight hours per week, you are insured against both occupational and non-occupational accidents. The insurance cover for non-occupational accidents exists as long as you are entitled to at least 50 per cent of your salary (for example, in case of a daily allowance received due to an illness or accident) and up to 31 days thereafter. If you register with the unemployment insurance authority before the end of this deadline, your insurance cover will be extended. For further details about how to proceed in case of unemployment, please contact the office responsible for such matters in your place of residence.

A case for negotiated insurance


Are you going to stop working permanently or temporarily, e.g. due to unpaid leave? By taking out negotiated insurance, you get guaranteed insurance cover for non-occupational accidents and in case of an accident, you will receive the full benefits pursuant to the provisions of the Federal Law on Accident Insurance (AIL). 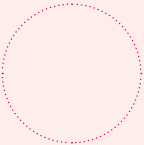

Taking out negotiated insurance

By paying in the premium amounting to CHF 40.- per calendar month commenced, you take out negotiated insurance. Please find a payment slip below. You must have paid the premium no later than on the day on which the company's accident insurance ends. In each case, you can extend your negotiated insurance for a total of six months at the most by paying the premium again.

Duration of the negotiated insurance

The negotiated insurance starts on the day following the end of the company's accident insurance cover. It expires once the insured person starts working for at least eight hours per week, but after six months at the latest. If you are insured by military insurance or foreign mandatory accident insurance, the negotiated insurance will be suspended.

I have had an accident. What should I do?
